COVID Experimental Jabs Are Violating the California Constitution and All Ten of the International Nuremberg Codes

June 8, 2021, in the San Rafael Community Center, Congressman Jared Huffman, of the 2nd District, held a Town Hall meeting, but it was not for everyone; it was only for those who have been vaccinated. People were to show proof of vaccination before they could enter. This is discriminatory and a violation of the California Constitution, but also international law – violating all ten codes of the Nuremberg Codes.

The California Constitution States:

- 1) Article I Sec. 3 people have the right to assemble freely, and public officials and agencies shall be open to the public.
- 2) Health and Safety Code 24170 prohibits UNLAWFUL COERCION to take any medical drug or health experiment (this vaccine is still labeled as an experimental). This is explained in the following:
- § 24171 (j) demands that people be given the opportunity to decide to consent or not to consent to a medical experiment without the intervention of any element of force, fraud, deceit, duress, coercion, or undue influence" on that decision.
- 3) California Civil Code § 51 protects our personal rights and states that all persons within the jurisdiction of this state are free and equal, and no matter what their sex, race, color, religion, ancestry, national origin, disability, medical condition, genetic information, marital status, sexual orientation, citizenship, primary language, or immigration status are entitled to the full and equal accommodations, advantages, facilities, privileges, or services in all business establishments of every kind whatsoever. [Notice no mention is made of vaccination status.] As Debra wrote, "Some people have medical conditions or religious objections to these injections, and Huffman's illegal exclusionary policy wasafter taking their right to access their government away from them."

The Nuremberg Codes: Dr. Reiner Fuellmich, a German attorney, who also practices law in California, has put together a

- team of 1,000 lawyers, and over 10,000 medical experts. They filed a class-action law suit May 3, 2021, and have begun their legal proceedings against the CDC, the WHO, and the WEF (the Davos Group) and others for "Crimes Against Humanity!" The law suit is going after three things:

 1) the faulty PCR test which was never designed to detect pathogens, but to just keep elevating the numbers of cases;
- 2) the fraudulent death certificates orders for doctors to label any comorbidity death as a COVID death; and
- 3) the "experimental vaccines." which are in violation of all ten of the Nuremberg Codes which carry the death penalty for those who seek to violate these International Laws. A synopsis:

Fuellmich and his team present the faulty PCR test and the order for doctors to label any comorbidity death as a Covid death as fraud. The PCR test was never designed to detect pathogens and is 100% faulty at 35 cycles. All the PCR tests overseen by the CDC are set at 37 to 45 cycles. The CDC admits that any tests over 28 cycles are not admissible for a positive reliable result. This alone invalidates over 90% of the alleged covid cases /"infections" tracked by the use of this faulty test.

In addition to the flawed tests and fraudulent death certificates, the "experimental" vaccine itself is in violation of Article 32 of the Geneva Convention. Under Article 32 of the 1949 Geneva Convention IV, "mutilation and medical or scientific experiments not necessitated by the medical treatment of a protected person" are prohibited. According to Article 147, conducting biological experiments on protected persons is a grave breach of the Convention.

Five Requirements a Vaccine is Supposed to Meet: Fuellmich states that the COVID "vaccine" fails all five: It is by definition a medical "experiment" and should have never been allowed to be given:

- 1) Provides immunity to the virus. This is a "leaky" gene therapy that does not provide immunity to Covid and claims to reduce symptoms yet double-vaccinated are now 60% of the patients requiring ER or ICU with COVID infections.
- 2) Protects recipients from getting the virus. This gene-therapy does not provide immunity and double-vaccinated people can still catch and spread the virus.
- 3) Reduces deaths from the virus infection. This gene-therapy does not reduce death from the infection. Double-Vaccinated people infected with COVID have died.
- 4) Reduces circulation of the virus. This gene-therapy still permits the spread of the virus as it offers zero immunity.
- 5) Reduces transmission of the virus. This gene-therapy still permits the transmission of the virus as it offers zero immunity.

Violation of all Ten of the Nuremberg Codes which carry the death penalty for those who seek to violate these International Laws. [Does that mean all those heads of state, governors, health directors, boards of supervisors, city councils, and media are guilty as they have been promoting and pushing the faulty tests and experimental vaccines on the rest of us?]

• Nuremberg Code #1: Voluntary Consent is Essential - No person should be forced to take a medical experiment without informed consent. No one had informed consent because no information as to the adverse effects or dangers of this gene-therapy was being given. All you hear is: "safe and effective" and "benefits outweigh the risks."

Countries are using lockdowns, duress and threats to force people to take this vaccine or be prohibited to participate in free society under the mandate of a Vaccine Passport or Green Pass. During the Nuremberg trials, even the media was prosecuted and members were put to death for lying to the public, along with many doctors and Nazis found guilty of Crimes Against Humanity.

- Nuremberg Code #2: Yield Fruitful Results Unprocurable by Other Means: There are other medical treatments that yield fruitful results against COVID such as Ivermectin, Hydroxychloriquine, Vitamin D, Vitamin C, Zinc and boosted immune systems from having recovered from a flu or cold.
- Nuremberg Code #3: Base Experiments on Results of Animal Experimentation and Natural History of Disease: This gene therapy skipped animal testing and went straight to human trials.
- Nuremberg Code #4: Avoid All Unnecessary Suffering and Injury: With over 4,000 deaths and 50,000 vaccine injuries in the U.S. and over 7,000 deaths and 365,000 vaccine injuries in the EU, this is a grievous violation of this code.
- Nuremberg Code #5: No Experiment to be Conducted if There's Reason to Think Injury or Death Will Occur: See #4, based on fact-based medical data this gene-therapy has caused much death and injury. Past research on mRNA also shows several risks that have been ignored. This experiment forces the body to produce this spike-protein inheriting all these risks.
- Nuremberg Code #6: Risk Should Never Exceed the Benefit: Covid-19 has a 98-99% recovery rate. The vaccine injuries, deaths and adverse side-effects of mRNA gene-therapy far exceed this risk. The CDC is fully aware that the use of leaky vaccines facilitates the emergence of hot (deadlier) strains. Yet they've ignored this when it comes to humans.
- Nuremberg Code #7: Preparation Must Be Made Against Even a Remote Possibility of Injury, Disability or Death: There were no preparations made. This gene therapy skipped animal trials. The pharmaceutical companies' own Phase 3 human clinical trials will not conclude until 2022/2023. These vaccines were approved under an Emergency Use only act and forced on a misinformed public. They are NOT FDA-approved.
- Nuremberg Code #8: Experiment Must Be Conducted by Scientifically Qualified Persons: Politicians, media and actors claiming that this is a safe and effective vaccine are not qualified. Propaganda is not medical science. Many retail outlets such as Walmart & drive-through vaccine centers are not qualified to administer experimental medical genetherapies to the uninformed public.
- Nuremberg Code #9: Anyone Must Have the Freedom to Bring the Experiment to an End at Any Time: Despite the outcry of over 85,000 doctors, nurses, virologists and epidemiologists the experiment is not being ended. In fact, there are currently many attempts to change laws in order to force vaccine compliance. This includes mandatory and forced vaccinations. Experimental 'update' shots are planned for every 6 months without any recourse to the growing number of deaths and injuries already caused by this experiment. These 'update' shots will be administered without any clinical trials. Hopefully this new Nuremberg Trial will put an end to this crime against humanity.


